

## **Singapore visa requirements below.**

- 1) Application Form **14A duly** completed and signed by the applicant
- 2) 1 recent passport-sized colored photograph against plain-white background **taken within the last three months.**  
Applicant **must not be wearing a white outfit** as it will conflict with the white background in the photograph.
- 3) Original Passport - must have a validity of more than 6 months upon entry in Singapore.
- 4) Copy of the Passport – Bio data page, renewals/extension, observation/amendment page (if there is), UAE residence visa page
- 5) Flight and Hotel reservation printout.
- 6) Visa fees AED 145
- 7) It will take **5 to 7** working days.

## **Mandatory Requirements TOURISM PURPOSE:**

- \*Letter of Introduction (LOI) must be issued by a local contact in Singapore. Any Singapore Citizen or Singapore Permanent Resident who is at least 21 years old can act as a local contact.
- Singapore ID copy of Invitee.
- Please provide colored copy of LOI – Signed with blue ink.

## **Mandatory Requirements: BUSINESS PURPOSE**

- Letter of Introduction (LOI – V39Form) with complete details of the inviting company (local contact in Singapore) i.e. Company name, Official Stamp & UEN number, inviting person's full name and NIRC number, Occupation/Designation, full address with postal code and telephone number.
- \*Letter of Introduction (LOI) must be issued by a local contact in Singapore. Any Singapore Citizen or Singapore Permanent Resident who is at least 21 years old can act as a local contact.
- Please provide colored copy of LOI – Signed with blue ink.

### IMPORTANT INSTRUCTIONS –

- Please bring 1 recent passport sized color photograph with white background within 3 months from the Photo Studio, if the photo is older than 3 months, the visa application will not be accepted.
- If Singapore visa application is submitted other than the applicant please provide the authorization form. ( Download the Authorization form here )
- Incomplete/illegible forms and /or documents submitted may result in the application being delayed or rejected.
- The applicant and the local contact in Singapore may be required to furnish additional documents and information whenever necessary.
- An application will be assessed by the Singapore Immigration and Checkpoints Authority based its own merits and supporting documents.
- Possession of a visa does not guarantee entry into Singapore. Visitors must also meet entry requirements such as holding a valid passport, sufficient funds for the period of stay in Singapore and confirmed onward/return ticket.
- Applicants can only apply for a visa within 30 days prior to entry to Singapore.
- Singapore Visa approval and visa validity is the sole discretion of Singapore immigration and checkpoint authority
- Please follow the above-given instructions as your application will be closely monitored by visa agents and Singapore consulate in Dubai.

**NOTE – Singapore visa fees will not be refunded if your visa is rejected.**
